# Migration Health Assessments for New Zealand-Bound Migrants

All applicants are required to undergo a migration health assessment as part of their visa application process for New Zealand. In this document, you will find important information related to your upcoming migration health assessment at IOM's Migration Health Assessment Centre (MHAC) in COLOMBO, SRI LANKA.

You will also be able to download this document at the end of the appointment-making process.

### What Should I Expect at my Appointment?

The scope of the migration health assessment varies depending on factors such on your visa category, age, gender and current health status. The list below shows some of the procedures that you or your family (if they are applying to migrate with you to New Zealand) might receive:

- > Registration.
- ➤ Counselling to explain the health assessment process (at the end of the counselling you will sign an informed consent form).
- Medical examination, which may include the following:
  - A review of your medical history and current symptoms
  - Taking your measurements and vital signs
  - A detailed physical examination to assess your physical and mental status
  - A chest X-ray
  - Hepatitis B and C tests

- Syphilis test.
- Serum creatinine (test for kidney function).
- HIV test.
- Full blood count.
- Glycosylated hemoglobin (test for diabetes).
- Pregnancy test.
- Urine analysis.

### Will I need additional tests or procedures?

Additional tests or treatment may be in order to complete the health assessment and/or to comply with the requirements of the immigration authorities, based on health conditions identified during your examination. In such an event, you will be provided with additional counselling and more information during your appointment.

### Will I receive any vaccines?

Immunizations are not currently required as part of the migration health assessment for New Zealand, unless special arrangements apply (such as immunization in case of outbreaks of vaccine-preventable diseases in the country of origin). However, you are strongly encouraged to complete immunizations before you travel to New Zealand and bring your immunization record with you. If you wish, the IOM doctor can review your record and provide advice on missing vaccinations.

## Important Notes

#### Minors:

Applicants under the age of 18 must be accompanied by a **parent or guardian** who can provide consent and make decisions on their behalf.

#### Pregnancy:

If you are pregnant and undergoing a migration health assessment, you may choose to either get the chest X-ray with a double leaded shielding to protect you and your unborn baby **or** wait to proceed with the migration health assessment until after giving birth.

If you choose to proceed with the chest X-ray, you will be requested to sign an additional consent form.

#### Tuberculosis (TB):

TB is a contagious bacterial infection that is spread from person to person through tiny droplets in the air. TB can be either:

- (1) Latent TB: when you have the bacteria in your body, but you don't have any clinical manifestations. In order to diagnose latent TB, active TB should be ruled out.
- (2) Active TB: when you have the bacteria and have clinical, radiological or laboratory manifestations.

You might be asked to undergo further testing if the doctor suspects you have TB. In such an event, you will be provided with additional counselling and more information during your appointment.

You will be requested to provide three (3) sputum samples over 3 consecutive days. These samples are then tested in a laboratory; it can take up to 8-10 weeks to obtain a result.

Good news! TB is treatable and most people can be cured with a few months of oral antibiotics.

### What Do I Need to Bring to My Appointment?

#### Identification:

- Passport (valid original)
- ► A copy of your passport with visa submission confirmation (if your passport is already submitted for visa)
- ▶ Photo ID of the accompanying parent/guardian, if applicant is a minor
- ▶ Children under 18 years old will need to bring their original birth certificate and Vaccination Card/Clinic Book

#### Medical Records:


- ▶ Any medical reports on past or current medical conditions.
- ▶ Child Health and Development Record for children, if available.

#### Other:

- ▶ Eyeglasses or lenses, if you wear them.
- ▶ Address in country of origin printed and in English.
- ▶ Address in the New Zealand printed and in English.

# Advice for the Migration Health Assessment

- ▶ For your physical examination, you will be asked to remove your clothes and will be provided with a medical gown, but please keep your underwear on (see image at right).
- ▶ You may request a chaperone to be present at your physical examination.
- ▶ Please do not conceal any medical conditions; deliberate attempts to hide them will be reported to the New Zealand immigration authorities.
- ▶ For female applicants, please do not conceal your pregnancy; being pregnant will have no impact on your immigration prospects.
- > Please note that, due to security and space limitations, only the applicant is allowed inside the premises.
- > Onsite parking is not available at the MHAC; please arrange to be dropped off or use taxi or bus services.
- Please arrive at the IOM Migration Health Assessment Center 15 minutes before your scheduled appointment time.
- Please postpone or re-schedule your appointment if you or your child are ill with a fever or have a rash.
- ▶ For female applicants, please postpone or re-schedule your appointment if you are menstruating, as it may affect the urine test result.
- ▶ There is no need to fast prior to your appointment.
